## 3 HAZARDS IDENTIFICATION

FIRE HAZARD : TOXIC FUMES (CHLORINE) ON DECOMPOSITION.  
INGESTION : MAY CAUSE GASTRO-INTESTINAL IRRITATION.  
IRRITANT : MAY CAUSE IRRITATION IN CONTACT WITH EYES.

## 4 FIRST AID MEASURES

EYES : Contact with eyes may cause IRRITATION. If symptoms persist seek medical aid. Irrigate with copious amounts of EYEWASH or clean water for 10 minutes minimum. If symptoms persist seek medical attention.
